Sub: Designation of Registration Centres for CMHIS.

No. SHA/CMHIS/2022/

:: The Chief Minister's Health Insurance Scheme (CMHIS) is

initiated by the State Government with the aim to provide free treatment of various ailments to all citizens of the State. The scheme will cover following beneficiary categories:

- a. CMHIS (EP) will comprise of State government employees, and pensioners including serving legislators/ exlegislators and their dependent family members.
- b. CMHIS (GEN) will comprise of all indigenous and/or Permanent residents of the State who are not beneficiaries under the AB PM-JAY or any public funded insurance scheme of the government and who are not covered under CMHIS (EP) category. CMHIS (GEN) beneficiaries also includes non-dependant family members of CMHIS (EP) categories, employees without PIMS number, contractual, adhoc, fixed pay employees of the State government and contractual employees under various CSS, and their household members.
- The online registration facility for Beneficiary household/ family under CMHIS is available at https://cmhis.nagaland.gov.in. The Online Registration can be done either by Self or through various Registration Centres.
- 3. All Primary Health Centre/ Community Health Centre empanelled under the AB PM-JAY CMHIS in the state and partner BIS Operators/ agencies are deemed authorized Registration Centres. Further, various departments at directorate and district offices are also designated as Registration Centres and are requested to setup Registration Centres for respective employees.

NB: Empanelled Card Vendors will setup Registration Centres at various DHs.

- 4. Registration Centres shall be responsible for Registration of beneficiaries from the State Beneficiary Portal and taking consent from the beneficiaries for creating ABHA Number and eKYC collection for generation of Ayushman Card from the BIS portal of National Health Authority. The details of the Eligibility Criteria, KYC documents required for registration and Workflow for Registration is available in our website at <a href="https://cmhis.nagaland.gov.in">https://cmhis.nagaland.gov.in</a>.
- 5. All Registration centres are permitted to charge from the beneficiary upto a maximum of Rs. 20.00 (Rupees twenty only) for every beneficiary household/ family registered, taking consent from the beneficiaries for creating ABHA Number and eKYC collected for generation of Ayushman Card for atleast one beneficiary in the household to meet the operational expenses.
- 6. The abovementioned designated registration centres are requested nominate a responsible officer as Single Point of Contact (SPOC) and operators, and submit their details in the prescribed format (Annexure: 1) to SHA through email to <a href="mailto:nagaland.nhpm@gmail.com">nagaland.nhpm@gmail.com</a> for registration/ creation of log-in ID for the operators.
