Annexure: 1

Terms of Reference

- A. Composition/Selection of Co-opted Members / Subject Experts:**
- 1) At least one medical expert representing each specialty.
  - 2) The medical experts should preferably be from different geographical locations of the State.
  - 3) In each specialty, no two experts can be from the same institute.
  - 4) The experts should be from both public and private sector with a minimum of 50% from public hospitals.
- B. Power and Functions of State Medical Committee:**
- 1) To formulate/ revise or customize the Health Benefit Package (HBP) master and provide advice for implementing State Specific HBP Master.
  - 2) Examination & recommendation / advice in regards of Unspecified Surgical Procedures (USP) up to Rs. 5.00 lakhs to the competent authority of the State Health Agency (SHA) / Nagaland Health Protection Society (NHPS)
  - 3) To frame policy for inclusion of frequently booked USP into State Specific HBP Master.
  - 4) To resolve State specific operational queries - clinical guidance to resolve various operational issues coming from empanelled hospitals and advice regarding HBP, drugs, devices, implants, including addition of new packages or deletion of packages from the package master as and when required.
  - 5) To assist in identification and monitoring of fraud/abuse; support in medical audit and fraud control by monitoring and evaluation at the ground level.
  - 6) To support in research and analytics; provide valuable policy level decision for seamless implementation of the scheme.
  - 7) Any other medical related matters as assigned by the NHPS
- C. Term of Office of the State Medical Committee Members:**
- 1) The term of Office of the Member and Co-opted Members shall be for 1 (one) year from the date of nomination which may be extended on a yearly basis.
  - 2) The term of Office of an ex-officio Member shall be for the term that he/she holds the Office by virtue of which he/she is such a member.
  - 3) An outgoing member shall, unless the NHPS otherwise directs, continue in Office until another person is nominated as a member in his/her place.
  - 4) An outgoing member shall be eligible for re-nomination subject to maximum of two terms.
- D. State Medical Committee Meetings:**
- 1) The meeting of the State Medical Committee shall be held at least once a month or as and when required either physically or virtually or in a hybrid mode.
  - 2) The Chairman shall call for a meeting of the State Medical Committee for discussion on issues pertaining to the State Medical Committee collected and compiled by the Member Secretary with the support from the NHPS.
  - 3) The Co-opted Members who are subject experts will be invited to the meeting based on the nature of the case.
- E. Logistics Support to State Medical Committee:**

The NHPS will provide necessary logistics support for smooth functioning of the State Medical Committee including provision of sitting allowance and travel expenses as per the laid down rules.
