NOTIFICATION

Sub: INCENTIVES FOR EHCPs UNDER CMHIS (EP).

The Chief Ministers' Health Insurance Scheme (CMHIS) is a fully cashless health insurance scheme of the Government of Nagaland. The employees and pensioners of the State Government and their dependents are covered under the CMHIS (EP) category with annual insurance coverage of Rs. 20.00 lakhs per Household.

Subsequent to the approval of the Government vide letter no: HFW-45/B/6/CMHIS/2022/303 dated 17th May 2023, the new incentive structure of the Health Benefit Package Rates for CMHIS (EP) category is notified as given in Annexure-1 for the current policy period w.e.f. 14th Oct 2022 to 13th Oct 2023.

All Empanelled Health Care Providers (EHCPs) are directed to ensure that cashless benefits are extended to all eligible beneficiaries of CMHIS (EP) category for all treatment including surgical, medical and identified day care procedures as listed out in the HBP.

Additional incentives over and above the published package rates

Table 1: Incentive Criteria & Gradation

Incentive Criteria	Incentive Gradation Above Base Package Rate ¹
1) Full NABH/ Joint Commission International (JCI) Accreditation	15%
2) Entry Level NABH / NQAS Certification	10%
3) Running PG / DNB Course in the Empaneled Specialty	10%
4) Private Hospitals based in Nagaland	40%
5) Autonomous Public Hospitals based in Nagaland (NHAK)	30%
6) Tier 1 Cities ²	30%
7) Tier 2 Cities ³	20%
8) Tier 3 Cities ²	10%

Note:

- 1) Base Package Rate¹: Nagaland HBP 2022 for CMHIS (EP) is based on the highest CGHS rates (Delhi/ Mumbai) (2014 rates) or AB-PMJAY rates .
- 2) These percentage incentives are added by *compounding*.
- 3) Incentive will be applicable for all surgical procedures, Dialysis and room charges only.
- 4) Above Incentives will not be applicable on the following:
 - i) Medicines and Consumables which are to be booked on actual cost.
 - ii) Implants
 - iii) Diagnostics, on which the following incentives will be applicable:
 - a. Rates of all diagnostic procedures will be enhanced by 50% of the Base Package Rate.
 - b. 15 % incentive on top of the Base Package Rate for NABL Certification.
- 5) Surgical package rate is inclusive of procedure, diagnostics, medicines, consumables and room rent while ICU is permissible and is to be billed separately in the event of complication needing ICU intervention.
- 6) Implants wherever required should be booked as an Add On procedure. If the beneficiary insists on high end implants which is beyond the package rate, the additional cost beyond the package rate will be borne by the patient provided a written consent is obtained from the concerned patient.
- 7) Relaxation: If the beneficiary insists on room facility which is beyond his/her entitlement, the additional cost beyond the entitled room rent will be borne by the patient provided a written consent is obtained from the concerned patient.
- 8) If the beneficiary wants to undertake a diagnostic test(s) which is not related to the ongoing treatment or health event, the cost of the diagnostic test(s) will be borne by the patient.
