Sub: Submission of Claims Utilization Report.

No: NHPS/Claim Utilisation/2023/921 :: As per this office letter **DHFW-8/AB-NHPM(PMJAY)/Misc/2018/3810-12**, Dt.Kohima8/July 2021 & email of even date, on the adherence of Guidelines for Claims Amount Utilization for Public Hospitals herein enclosed as **Annexure 1**, all public hospitals are to submit the Quarterly Reports (QR) on utilization of claims amount on or before the 10th of the quarter end.

Whereas, many public hospitals are not submitting the QR despite the generation of substantial revenue from the claims under AB PM-JAY and CMHIS. The issue of proper utilization of revenue generated from the claims as per the guidelines by the public hospitals is a concern for the Government and was flagged on several occasions.

Therefore, subsequent to the direction of the Government, no further payment will be released to those public hospitals defaulting in submission of QR from the date of receipt of hospital claims under PM-JAY (w.e.f. 2018) & CMHIS (w.e.f. 2022) till date as per the guidelines. This direction will be enforced with immediate effect.

Further, all public hospitals are directed to strictly comply with the Guidelines for Claims Amount Utilization For Public Hospitals and is subject to CAG Audit as per Government Policy vide No: HFW-28/AB-NHPM/2018/22 dated 17th Dec 2020 herein enclosed as **Annexure 2**, failing which necessary disciplinary action as deemed fit will be initiated.
