## MAJOR POINTS

- 1. SHA shall follow the following steps for the selection process:
  - a. the total Bid price of each bidder shall be computed across the 3 (three) Quotations (multiplication of the Bid price per family with minimum committed number of families for the respective categories) and summed up.
  - b. The bidder with the lowest total bid price shall be considered as Lowest Gross Insurance Premium (L-1).
  - c. If there is only one L-1 bidder, that bidder shall be selected as the successful bidder.
  - d. In case two or more bidders have the same lowest total premium (rounded off to two decimal points), lowest bidder for financial Quotation for PM-JAY and CMHIS(GEN) will be asked to match the Lowest bid for Quotation 2 , and Quotation 3.
  - e. If the Lowest bidder for Quotation 1 agrees to match the Lowest bids for Quotation 2, and Quotation 3 as set out in Clause 10.4.3 a, the Lowest bidder for Quotation 1 shall be declared as the ‘Selected Bidder’ else the second lowest bidder for Quotation 1 shall be approached to match the Lowest bids for all 3 Quotations categories.
  - f. If the L2 bidder agrees to do as set out in Clause 10.4.3. b, the bidder shall be declared as the ‘Selected Bidder’, else the L3 bidder shall be asked to match the L1 Quotations of all 3 categories and so on.
  - g. The process shall be repeated till the ‘Selected Bidder’ is identified.
- 10.4.4 If a successful bidder cannot be identified through steps in clause 10.4.3, the Successful Bidder will be selected through lottery amongst the bidders with the same lowest total premium.

## MAJOR POINTS

- 2. Field Investigation and Medical Audit has been removed from the RFP, in deviation to the MTD issued by NHA.
- Separate agencies to take up Field Investigation and Medical Audit
- 3. ITB 1.9 Rewarding Healthy Behaviour:  
With a view to address the drivers of preventable rehospitalization/repeat hospitalizations leading to spiraling cost of Public Health-insurance and as a step towards Value-based insurance design (VBID), the Insurer shall incentivize beneficiaries to work towards better health. The rewards in form of health coupons/any other form mutually decided by state government and the Insurer shall be given to members families, participating in digital/physical health assessment, organized by state / insurer or any appointed agency.
