**OFFICE MEMORANDUM**

In continuation to this department's OM of even no dated 7<sup>th</sup> November 2022, 14<sup>th</sup> June 2023 and 19<sup>th</sup> June 2023, where it concerns eligibility of Government employees and pensioners under CMHIS(EP), the following instructions are hereby issued for strict compliance:-

1. **Deceased Family Pensioners:** Following the demise of a Family Pensioner, CMHIS(EP) coverage for the remaining dependents shall be extended only if one of the dependents is eligible for Family Pension and shall continue contribution to the CMHIS corpus under the Pensioner category.
2. **Employees awaiting Pension processing:** When a Government employee retires but has not completed the pension processing formalities, the individual shall continue to be covered under CMHIS (EP) during this interim period. The retiring employee shall not be required to make a fresh CMHIS card, as contributions and entitlements remain unchanged.
3. **Demise of serving Government Employee:** In the event of demise of a serving Government Employee, the affected family/dependents shall continue to be covered under CMHIS(EP), if any of them are entitled to Family Pension.
4. In all the above cases, outstanding contribution arrears shall be recovered from the first payment once Pension/Family Pension is settled.
