**CLARIFICATION**

Apropos to the Press Statement of the District Pensioners Association, Mokokchung, this is for the information of all concerned that the health insurance coverage under the Chief Minister Health Insurance Scheme (CMHIS) is effective from the date of commencement of the scheme, i.e. 14<sup>th</sup> October 2022.

The Scheme was initiated with the aim to alleviate financial hardships due to hospitalization expenses and to prevent inaccessibility to medical care on account of unaffordability, by providing free and cashless benefits for treatment of various ailments, to every citizen of the State who are not covered under AB PM-JAY. Benefits can be availed from any empanelled hospital within and outside the State using the CMHIS Card. The details of empanelled hospitals are available at <https://cmhis.nagaland.gov.in>.

To obtain the card, CMHIS (EP) and CMHIS (GEN) beneficiaries are to first register and upon approval of their registration will receive a Household ID No (HH ID) through SMS on their registered Mobile Number. Aadhaar based eKYC will be collected using the Household ID (HH ID) for generation of the Ayushman CMHIS Card for every member of the household.

For CMHIS (GEN) beneficiaries having NFSA Ration Card, registration in the State Beneficiary Portal is NOT required and such beneficiaries can directly obtain the Ayushman CMHIS Card for every member of the household following Aadhaar based eKYC collection.

Many Government Employees and Pensioners have submitted the Forms to their respective offices. Considering the inherent problems associated with manual collection of information, all Government Employees and Pensioners are requested to apply for registration online at <https://cmhis.nagaland.gov.in> even though they may have already submitted the hard copy. This will ensure faster registration for all Government Employees and Pensioners.

To facilitate registration of beneficiaries and card issuance, Registration Centres have been setup in various Government Establishments (Directorates, DC Office, District Offices of different Departments) and Health Facilities (District Hospital, CHCs, PHCs). It can also be done through Common Service Centres, Village Level Entrepreneur (VLE), UTIITSL and other BIS Partners. Further, Special Enrolment Drive is being organised across the State with an aim to expedite saturation of the scheme (beneficiary registration & card issuance). The schedule of the Special Enrolment Drive will be sent to the Village Council/ Town Wards by respective Deputy Commissioners. The district wise schedule for the Special Enrolment Drive is available at <https://cmhis.nagaland.gov.in>.

The 50% amount deducted of the monthly Medical Allowance from State Government Employees and pensioners w.e.f. salary of November 2022 onwards is maintained under a dedicated Public Account (Major Head: 8011- Insurance & pensions Funds, Sub Major head: 00, Minor Head: 105- State Government Funds & Scheme Head: Chief Minister Health Insurance Scheme) specially created to ensure proper accountability and transparency vide OM No: FIN/BUD/15-3/2022-23 dt 7<sup>th</sup> Nov 2022.

Beneficiaries under CMHIS (EP) category are informed of the following:

1. When both spouses are government employees or pensioners or one spouse is government employee and the other is pensioner, they should register as a single household.
2. Spouse drawing higher pay should be declared as Head of Household and other spouse will be declared as member.
3. If other members of the Household are government employees or pensioners, they should be registered as a separate household. Further, the dependant family members will be registered with any of the above mentioned household provided the conditions of dependencies are fulfilled.
4. All non-dependant family members will be considered a household under CMHIS (Gen) category.
5. To provide the list of all members of the household irrespective of dependant or non-dependant family members at the time of registration.

It is also possible that some government employees and pensioners may be in possession of AB PM-JAY Card. Such government employees and pensioners can obtain the CMHIS Card and access the benefits under CMHIS only after disabling the AB PM-JAY Card. Therefore, the AB PM-JAY Card may be surrendered and disabled by sending a scanned copy of the AB PM-JAY Card through email to [nagaland.nhpm@gmail.com](mailto:nagaland.nhpm@gmail.com).

We appeal to all beneficiaries to register at the earliest and obtain the AYUSHMAN CMHIS Card in order to be prepared for untoward eventualities.

The procedure to apply for CMHIS Card for Pensioners is as follows:

**Step 1:** Register in the CMHIS portal at <https://cmhis.nagaland.gov.in/> or through any of Registration Centres set up at Finance Department /Deputy Commissioner's Office / District Hospital / CHCs / PHCs / District Offices of various Departments

(Documents Required: First 3 pages of PPO book and Personal Details)

**Step 2:** Verification and Approval of the application for registration by Finance Department. A confirmation SMS would be sent on registered Mobile No. indicating new assigned Household ID for the Pensioner's household/family

**Step 3:** Apply for Ayushman Bharat CMHIS eCard at any CSC/District Hospitals Aadhaar Card is mandatory.

**Step 4:** The Insurance Company/TPA/SHA will verify the entered details with Aadhaar for Approval/Rejection within 30 mins

**Step 5:** If Approved, Download and Print the AB-PMJAY CMHIS Card


