This is to notify that, the State Government had implemented the Chief Minister's Health Insurance Scheme (CMHIS) by extending Health Insurance to all State Government and their dependents on 1st October 2022.

As such, as per Government letter No HFW-7/B-15/2019/329 Date 2nd Dec 2022, all Outside State Treatment & Medical Re-Imbursement system for Government servants will be discontinued with immediate effect. However, on-going treatment / under treatment may continue till discharged subject to settlement of Medical re-Imbursement bill within six months W.e.f 1st Oct 2022.


Sub: **Clarification on matter regarding Discontinuation of Outside State Treatment & Medical reimbursement**



Sub **Discontinuation of Outside State Treatment & Medical Re-Imbursement**

Sir,

As you are aware, the State Government will be implementing the Chief Minister's Health Insurance Scheme (CMHIS) by extending health insurance coverage to 1). State government employees and pensioners including ex-legislators, family pensioners and their dependents, which is categorized as CMHIS (EP) and (2). all the indigenous and permanent residents of the State who are not covered by AB PM-JAY and are not State government employees and pensioners including ex-legislatures, which is categorized as CMHIS (GEN). The scheme is scheduled to be launched tentatively on 1st Oct 2022.

Accordingly, the existing Outside the State Treatment & Medical Re-imburement system for Government servants will be discontinued and shall stand replaced. Employees and Pensioner including ex-legislators and family pensioners and their dependents of the State Government will now avail the cashless benefits for treatment of various medical conditions under CMHIS (EP) category of the Scheme

In this regard, you are requested to submit a proposal to Government on the modalities for discontinuation of the existing Outside the State Treatment & Medical Re-imburement system at the earliest time possible.

The proposal should also address modalities to ensure cases that are undergoing/ under treatment to continue their treatment till their medical re-imburement bill is settled but not exceeding a maximum period of 3 months starting from 1st Oct 2022.
