Sir,

Pursuant to the Right to Information Act 2005, I hereby request the following information from your office:

1. Total Amount Deducted:  
Please provide the total amount of money deducted from Government employees and pensioners under the AB PM-JAY CMHIS scheme from November 2022 to May 2024.
  2. Deposits to Insurance Companies:  
Provide details of the amounts deposited to various insurance companies during the same period (November 2022 to May 2024).
  3. Treatment Facilities Comparison:  
It has been observed that Central Government employees receive comprehensive treatment facilities in empaneled hospitals, whereas the CMHIS scheme does not cover some major surgeries. Please provide the reasons for this discrepancy and the steps being taken to address it.
  4. Reimbursement for Unreceived Facilities:  
Many patients registered under CMHIS and treated at empaneled hospitals report not receiving the intended facilities. Will such patients be reimbursed? If not, please provide the reasons.
  5. Number of Registered Employees and Pensioners:  
Provide the total number of employees and pensioners registered under the CMHIS scheme as of the latest date available.
  6. Empanelment of CMCH Vellore:  
CMCH Vellore is not yet empaneled under CMHIS. Please provide updates on the status of its empanelment.
  7. Bank Account Details and Balance:  
In which bank is the money collected under CMHIS kept? Provide the available balance from November 2022 to 31st May 2024. Also, provide proof of the amount received and the total amount deposited to insurance companies during this period. How many beneficiaries have received help from CMHIS?
  8. Monthly Deductions:  
If ₹400 is deducted from every Government employee and pensioner, please provide the total amount collected in one month.
- I am enclosing a postal order of ₹10 as the application fee as per the RTI Act. Kindly provide the information at the earliest as per the provisions of the RTI Act.
